With the arrival of the warm weather and the enjoyment of Spring Break in our rear-view mirror it signals that summer is approaching us quickly. It has been a busy preseason getting our special projects aligned and scheduled (see below for more details). **Special Projects Update:**

We wanted to provide you updates on the projects where the special assessment monies were assigned to:

1. **Roof:** Repairs are complete. Minor adjustments to exhaust fan and piping remain (to be completed by Opening Day).
2. **Furniture:** The board has made a decision on upgraded chairs, umbrellas that we feel the membership will be happy with. Orders have been placed with arrival prior to opening.
3. **Pool pump room and equipment:** Work has been scheduled and will be complete prior to opening.
4. **Electrical upgrades:** Work has been scheduled and will be complete prior to opening.
5. **Fence Extension:** Putting together the permit for submission and are hopeful to have it completed prior to opening. Proposed drawing has been included in this communication for feedback from members prior to approval.
6. **Handicap chair:** This project has become larger in scope (permitting and engineering costs) than originally intended or budgeted for. The Board has decided to delay this project until next year and secure the budgeted \$3500 collected in the assessment into a savings account to be applied when the project resumes.

We appreciate those families who have made the total payment of \$218 and ask any of you who have an outstanding balance to please pay as soon as possible so that we can pay invoices on the above projects. Please feel free to reach out to the board with any additional questions on these projects.

**Important Dates and Reminders:**

Our pool community has thrived on the volunteerism of its members. In order to keep expenses down we typically have 2 “maintenance days” where we ask members to come and help with opening of the pool. Tasks include staging and cleaning of furniture and equipment, general upkeep of grounds, cleaning of deck and other amenities, and organization/cleaning of clubhouse and locker rooms. The pool maintenance days are currently scheduled for **Sunday, May 2<sup>nd</sup> and May 23<sup>rd</sup>**. We will be sending out reminders and task sign-ups as we get closer to the dates.

Our social co-chairs are looking to put together a “Tailgate Fiesta” on our grounds for members to come and enjoy an outdoor social gathering prior to the pool opening. Target date is currently Friday May 21<sup>st</sup>, with Saturday May 22<sup>nd</sup> as a rain date, so mark your calendars. More information to follow in a separate communication.

\*The Board does have an open Maintenance Chair position previously filled by Pat Driscoll. We want to thank Pat for his many years of service – he will be greatly missed this season. This position facilitates general grounds maintenance upkeep and service as needed and has a key role on the board.
